



## EVA PARK LIFE & SPA SWIMMING POOL AND WELLNESS ZONE RULES AND REGULATIONS DURING THE CORONAVIRUS PANDEMIC

1. The maximum number of persons that may be present in the Swimming Pool/Wellness Zone at any one time is 15.
2. Every person visiting the premises of EVA Park Life & SPA is required to disinfect their hands immediately upon entry.
3. A person with symptoms of an infection, in particular of an upper respiratory tract infection, must not use the swimming pool zone. The reception desk staff is authorised to measure the body temperature of every Guest with a non-contact infrared thermometer. Our staff member may refuse entry to the swimming pool to any Guest who either refuses to have their body temperature measured or presents symptoms of an infection, including fever exceeding 37.5°C (99.5°F).
4. All Guests must keep a minimum distance of 2 metres from other guests/staff members in the reception area as well in the changing rooms, toilets, shower rooms, hot tubs and when swimming in the pool.
5. Only one Guest may be present in the immediate area of the swimming pool reception desk.
6. All swimming pool users are required to carefully wash their whole body under the shower before entering the pool area. Strict separation between the dry and wet areas must be observed at all times. Before entering the pool area, all users must wash their feet in the designated foot-washing station.
7. There can be no more than 4 swimmers using one swimming track at any one time.
8. If it is not possible to keep the minimum distance of 2 metres, a hot tub may only be used at any one time by one person or by a group of people who share a household.
9. The use of saunas is restricted. In accordance with the applicable recommendations of the Chief Sanitary Inspectorate, the wet steam sauna will remain closed until further notice due to the temperature lower than 60°C (140°F). The maximum number of persons using the dry sauna at any one time is 2. Every Guest using the dry sauna must be barefoot, without any body covering except for a towel. The door must be closed to maintain the required temperature inside.
10. All persons using the Swimming Pool/Wellness Zone must keep their mouths and noses covered with a mask at all times while on the premises of EVA Park Life & SPA, except for when showering and using in the pool. The mouth and nose cover should be removed and left in the changing room locker together with other clothes, before directly proceeding to the shower room and the foot-washing station and then entering the pool area. The mouth and nose cover should be immediately put back on in the changing room when getting dressed after swimming.
11. Every person using the EVA Park Life & SPA Swimming Pool/Wellness Zone is requested to limit their stay in the zone to the time of swimming in the pool and changing clothes.
12. Due to the mandatory regular disinfection of the general access areas at the reception desk, the changing rooms and the swimming pool, 15-minute technical breaks in swimming pool use are allowed up to several times a day.
13. In addition to the provisions of these EVA Park Life & SPA Swimming Pool/Wellness Zone Rules and Regulations during the Coronavirus Pandemic, every Guest is also required to observe the EVA Park Life & SPA Swimming Pool Zone/Wellness Rules and Regulations.
